




Durability (inductive load) = durability (resistive load) x reduction coefficient. Resistive AC load



X Switching capacity (kVA)


**Y** Durability (Number of operating cycles)


Reduction coefficient for inductive AC load (depending on power factor  $\cos\varphi)$
